(VARIOUS ROADS, DISTRICT OF BLABY) CONSOLIDATION ORDER 2017
(VARIOUS ROADS IN THE DISTRICT OF BLABY) (AMENDMENT 15) ORDER 201

THE LEICESTERSHIRE COUNTY COUNCIL hereby gives notice that it proposes to make an Order under Sections 1, 2, 4, 5, 32, 35, 45, 46, 47, 49 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, the effect of which will be:

- 1 To remove the existing restriction of No Waiting at any Time on parts of Lyndale Road and Ravenstone Road, Braunstone
- 2 To remove the existing restriction of No Waiting Monday – Friday 8am – 6pm on parts of Cambridge Road, Whetstone, Lyndale Road, Braunstone and Green Lane and Wigston Street, Countesthorpe
- 3 To remove the existing restriction of No Waiting Monday – Saturday 8am – 6pm on parts of King Street, Enderby Barwell Road, Castle Road, Kirby Muxloe, Church Lane, Bell Lane, Jubilee Crescent, Leicester Road, Princess Street, Regent Street, Victoria Street, School Lane, Thornton Drive and Victoria Street, Narborough and Enderby Road, Whetstone
- 4 To remove the existing restriction of No Waiting Monday – Saturday 7.30am – 9am and 4.30pm – 6pm on parts of Bassett Avenue, Station Road and Waterloo Crescent, Countesthorpe and High Street and Church Lane, Whetstone
5. To impose No Waiting at any Time on parts of Barwell Road, Kirby Muxloe, Avon Drive, Cambridge Road, Church Lane, Enderby Road, High Street and Wale Road, Whetstone, Bassett Avenue, Green Lane, Station Road, Waterloo Crescent and Wigston Street, Countesthorpe, Church Lane, Bell Lane, Jubilee Crescent, Leicester Road, Narborough, Princess Street, Regent Street, School Lane, Thornton Drive and Victoria Street, Narborough.

A copy of the proposed Order, together with a plan illustrating the proposal and an explanatory statement giving the Council's reasons for proposing to make the Order may be inspected during normal office hours at my offices, Room 200, County Hall, Glenfield, Leicester LE3 8RA at the offices of Blaby District Council, Desford Road, Leicester LE19 2EP, and on the Notice Boards of the various Parish Councils.
