The proposed changes to the access and parking in the amended application are not, in our view, any improvement on the original proposal and are still unacceptable. Vehicle movements in and out of the proposed new dwelling would be close to a busy junction with poor visibility, especially as the nearby lay-by-area is not only used by buses but also visitors to the shops and pub on the other side of the road. We also feel that the proposed surface water disposal to soakaway is unacceptable.
