1. PURCHASE OF EXCLUSIVE RIGHT OF BURIAL (RESIDENTS OF NARBOROUGH & LITTLETHORPE ONLY)		
a)	For the exclusive right of burial in an earthen grave space 108 inches x 48 inches or 274 cm x 122 cm Sections B, C, D, E, H, J, K, L	£400.00
b)	For the exclusive right of burial in a <u>premium</u> earthen grave space <u>next to path</u> 108 x 48 inches or 274 cm x 122cm Sections B, C, D, E, H, J, K, L	£500.00
c)	For the exclusive right of burial of a stillborn child (and up to 3 months old) in an earthen grave space 54 inches x 48 inches feet or 137 cm x 122 cm (single interment) in specified area sections D and H	Free of Charge
d)	For the exclusive right of burial of cremated remains in an earthen grave space 24 inches x 24 inches or 61cm x 61 cm Sections A, M and R	£200.00

All purchased plots must be paid for and an interment arranged within a 4 week period. Plots may no longer be pre-purchased for future use

2. INTERMENTS		
a)	For the interment of any remains in a grave for which an Exclusive Right of Burial has been purchased, including cremated remains.	£200.00
	For the interment of any remains in a grave for which an Exclusive Right of Burial has been purchased, including cremated remains for a non-parishioner	£600.00
b)	Cremated Remains Plots ONLY - plot preparation fee	100.00

	iv) Addition of kerb stones or a flat stone on top of kerb stones (non-parishioner)	£100.00

	Additional inscription on any memorial (non-parishioner)	£100.00
d)	Replacement Memorials	£50.00

c)	Interment arrangements made directly with Parish Office (without a funeral director being present)	£100.00
